

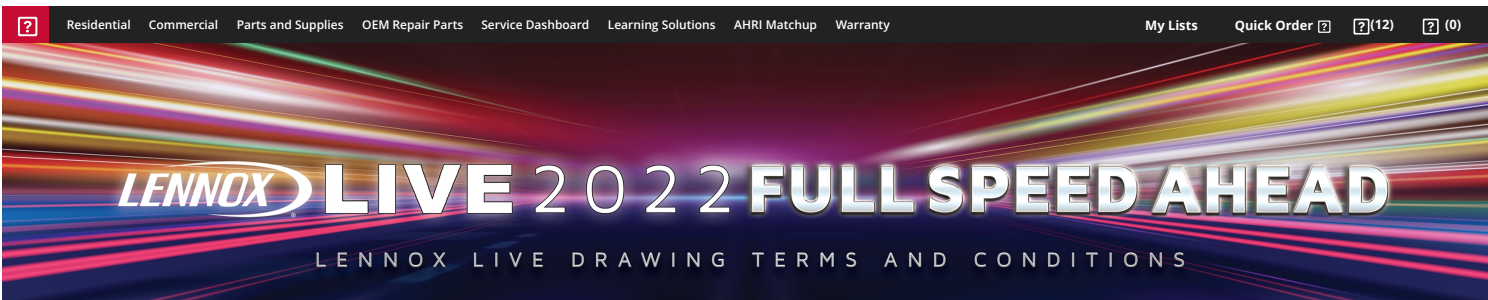

LennoxPros Web Training Sweepstakes Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

OPEN TO LEGAL RESIDENTS OF THE UNITED STATES AND CANADA (EXCLUDING QUEBEC) WHO HAVE REACHED THE LEGAL AGE OF MAJORITY IN THEIR JURISDICTION OF RESIDENCE AND WHO ARE EMPLOYEES OF A LENNOX TM-ASSIGNED DEALER. VOID IN QUEBEC AND WHERE PROHIBITED OR RESTRICTED BY LAW.

- 1. GENERAL:** The LennoxPros Web Training Sweepstakes (the “Sweepstakes”) is sponsored by Lennox Industries Inc., 2100 Lake Park Boulevard, Richardson, Texas 75080 (“Sponsor”). The Sweepstakes is subject to these Official Rules and to all applicable federal, state, provincial/territorial, and local laws. Void in Quebec and where prohibited or restricted by law.
- 2. ELIGIBILITY:** The Sweepstakes is open to legal residents of the United States and Canada (excluding Quebec) who have reached the legal age of majority in their jurisdiction of residence and who are employees of a Lennox TM-assigned dealer as of the date of entry. Employees, officers, and directors of Sponsor, its parent company, subsidiaries, affiliates, advertising agencies, promotional suppliers, prize providers (collectively, “Sweepstakes Entities”) and the immediate family members (spouses, parents, children and siblings and their spouses) or members of the same household (whether related or not) of such individuals are not eligible to enter or win.
- 3. HOW TO ENTER:** Enter by registering for a personalized, one-on-one LennoxPros Web Training at <https://www.lennoxpros.com/schedule-demo> and completing such training during the period beginning at 12:01 a.m. Central Time on March 4, 2022 and ending at 11:59:59 p.m. Central Time on May 1, 2022 (the “Entry Period”) or by printing out the entry form available at http://images.lennoxpros.com/is/content/LennoxIntl/web-dev/2022/2202/PDF/Entry_Form_2022.pdf (“Entry Form”) and mailing a fully completed Entry Form to Lennox at LennoxPros.com, ATTN: Tony Hinojos 2100 Lake Drive Blvd, Richardson TX 75080 that is received during the Entry Period.

Entrants will be automatically entered in the Sweepstakes upon completion of the LennoxPros Web Training or receipt of the Entry Form by Lennox during the Entry Period. Failure to attend and complete the training by expiration of the Entry Period makes you ineligible for entry unless Lennox receives a completed Entry Form from you during the Entry Period. Entry Forms received by Lennox after the Entry Period are ineligible.

- 4. PRIZES AND ODDS:** There are thirteen prizes (each, a “Prize”) available to be won:
 - 2 Yeti Tundra 65** (Approximate retail value (“ARV”) = US \$375/CAN \$500)
 - 3 Canon EOS Rebel T6 SLR Camera** (ARV = US \$449/CAN \$599)
 - 4 Audio-Technica AT-LP120USB Turntable** (ARV = US \$349/CAN \$449)
 - 3 GO Pro Hero 7** (ARV = US \$349/CAN \$459)
 - 1 Bose Soundlink Revolve Plus** (ARV = US \$329/CAN \$399)

Any difference between the ARV and the actual value of the prizes will not be awarded. The prize will be considered compensation to the winners.

All federal, state, provincial/territorial, municipal, and local taxes associated with receipt or use of a prize are the sole responsibility of winner. For US winners, Sponsor will file an IRS Form 1099 for the value of the prize if legally required to do so, and in that instance, the winner will be required to furnish his or her social security number and complete and return an IRS W-9 form for purposes of same. Canadian winners are solely responsible for the reporting and payment of any taxes relating to their prize. **Please note that there is no cash award associated with the prizes.**

Odds of winning depend on the number of eligible entries received in the Entry Period at the time of drawing. All methods of entry provide the same odds of winning.

- 5. WINNER SELECTION AND NOTIFICATION:** On May 16, 2022, Lennox will select thirteen (13) winners by randomly drawing from among all eligible entries received during the Entry Period. Winners will be denoted as Winner #1, Winner #2, Winner #3, etc., in the order in which their name is randomly drawn, and each winner will select their prize in the order they were randomly drawn (e.g., Winner #2 will select their prize after Winner #1). Each winner will be notified via email or phone number at the email/phone number provided at time of entry and must respond to the notification of their prize selection within fourteen (14) days, or that winner will be disqualified and another potential winner selected. Drawings will be conducted by Sponsor or Sponsor's representative, whose decisions are final and binding. Limit one (1) prize per household. Prizes will be shipped to the address provided by the winner to Lennox, approximately four (4) weeks after the end of the drawing. Customer is responsible for making sure contact information is current and accurate.

FOR CANADIAN RESIDENTS ONLY: Prior to being confirmed as a winner, any eligible winner from Canada will be required to correctly answer a mathematical skill-testing question without mechanical or other aid. If a potential winner is found to be ineligible, or does not or cannot comply with these Official Rules (including, but not limited to, the requirement for a potential winner who is a resident of Canada to correctly answer a mathematical skill-testing question without mechanical or other aid), that potential winner will be disqualified, and an alternate potential winner will be selected.

- 6. GENERAL TERMS AND CONDITIONS:** To the fullest extent permitted by applicable law, all issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor or the other Sweepstakes Entities in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Texas, without giving effect to any choice of law or conflict of law rules. Any and all disputes, claims, and causes of action arising out of or in connection with this Sweepstakes or any prize awarded shall, to the fullest extent permitted by applicable law, be resolved exclusively in the appropriate federal or state court located in Dallas County, Texas, and entrants hereby consent and submit to the personal jurisdiction of such courts. UPON SUBMISSION OF AN ENTRY TO THE SWEEPSTAKES, YOU WAIVE YOUR RIGHT TO CONTEST JURISDICTION AND VENUE IN DALLAS COUNTY, TEXAS. Sponsor reserves the right, in its sole discretion, to substitute one or more elements of a prize for a prize of equal or greater value. Except as determined by Sponsor in its sole discretion, no substitution of prize is offered, no transfer of prize to a third party is permitted, and prize may not be redeemed for cash value. Any difference between stated ARV of prize and actual value of prize will not be awarded. Any portion of prize not accepted by winner will be forfeited.

- 7. ACCEPTABLE CONDUCT:** By entering this Sweepstakes, entrants agree to be bound by these Official Rules and the decisions of the Sponsor or Sponsor's representative, which shall be final and binding in all respects. Failure to comply with these Official Rules may result in disqualification. Sponsor reserves the right at its sole discretion to disqualify any individual suspected of tampering with the entry process or the operation of the Sweepstakes; or to be acting in any manner deemed by Sponsor to be in violation of the Official Rules; or to be acting in any manner deemed by Sponsor to be unsportsmanlike or disruptive, or with intent to annoy, abuse, threaten, or harass any other person. - 8. LIMITATIONS OF LIABILITY:** Sponsor assumes no responsibility or liability for: (a) any incorrect or inaccurate registration or entry information, or for any faulty, failed, garbled, or jumbled electronic data transmissions; (b) any unauthorized access to, or theft, destruction, or alteration of entries at any point in the operation of this Sweepstakes; (c) any technical malfunction, failure, error, omission, interruption, deletion, defect, delay in operation, or communications line failure, regardless of cause, with regard to any equipment, systems, networks, lines, satellites, servers, computers, or providers utilized in any aspect of the operation of the Sweepstakes; or (d) any injury or damage to participant's or to any other person's computer, cell phone, or other device which may be related to or resulting from any attempt to participate in the Sweepstakes or download any materials in the Sweepstakes. 9. **RELEASES:** All entrants, as a condition of entry into the Sweepstakes, agree to release the Sweepstakes Entities from and against any and all liability, claims, or actions of any kind whatsoever for injuries, damages, or losses to persons or property which may be sustained in connection with: submitting an entry or otherwise participating in any aspect of the Sweepstakes; the receipt, ownership, or use of any prize awarded; or any typographical or other error in these Official Rules or the announcement or offering of any prize. Each winner shall bear all risk of loss or damage to their prize after it has been delivered. Sponsor makes no representations or warranties of any kind concerning the appearance, safety, or performance of any prize. Except for residents of TN and where prohibited by law, winner grants to Sponsor the right to print, publish, broadcast, and use worldwide in any media now known or hereinafter known (including without limitation use online at Sponsor's website, social media pages, or via Tweet) the winner's name/authorized dealer name, voice, statement, picture, or other likeness, without additional compensation, for public relations, advertising, and promotional purposes as may be determined by Sponsor.
