- Orders can be e-mailed to CSMarketingOrders.
- No vendor direct, or commercial product allowed on this promotion.
- Copper, commodities & refrigerant are not allowed on this promotion.
- No Consignment orders.
- All products are subject to availability in certain markets.
- All sales on Surplus Inventory Sale are final and sold while supplies last on a first come first served basis. No price substitutions will be offered.
- All orders or changes to orders must go through your Territory Manager or Field Sales Representative, who will forward to the Program and Services team.
- Order must include \$3,000 purchase of parts and supplies to be eligible for free product benefits.

Credit Terms

- All orders and terms are subject to credit approval.
- New credit accounts must submit credit application, which will be processed through Credit Services
- within three (3) business days.
- Once account is approved, Customer Service will then begin to process the qualifying order.
- Credit terms are available on order levels earned.
 - \$20K to \$49.9 receive (NR) terms 1/3 Standard, 1/3 30 days, 1/3 60 days extended.
 - \$50K+ receive (NS) terms 1/3 30 days, 1/3 60 days, 1/3 90 days extended.
 - \$100K+ orders receive (UR) terms 1/4 30 days, 1/4 60 days, 1/4 90 days, 1/4 120 days extended.
 - UR, NS and NR terms receive early payment discounts. Early Pay Discount is calculated identically to any regular order and no additional Early Pay Discount is offered for the Stocking Promotion. Contact your Credit Representative for more information.
- Any orders on credit hold at the end of the program or orders for which dealer has refused shipment will be canceled.
- At the end of the program, any unshipped portion of a qualifying order delayed due to Lennox's inability to supply product will receive extended credit terms upon shipment.
- Delinquent accounts will be reviewed prior to receipt of any benefits.

Benefits

- A dealer cannot combine orders to achieve a higher amount of benefits.
- Orders will receive free product benefits based on the offers provided. Lennox reserves the right to review and modify free product benefits.
- Free product must be specified before the order can be shipped.
- Lennox Premier Dealers™ earn additional free product (see flyer for details).
- Dealer account must be set up on the Lennox SAP system as an eligible Lennox Premier Dealer™ prior to order placement.
- Free product benefits will be calculated at dealer Zone/Net price. This offer cannot be cumulated with any other special or promotion.
- Order must include \$3,000 purchase of parts and supplies for parts and supplies to be eligible for free product benefits.

Exchanges/Returns

- Lennox reserves the right to refuse any returns or exchanges.
- If any portion of the order is returned, the associated free product earned must be returned.

Shipping

- North American freight policy applies.

- Orders are limited to a maximum of three (3) shipments.
- Lennox will schedule each truckload and/or split load and confirm ship date with the customer prior to shipment.
- Once the order has completely shipped and billed, it is closed and cannot be added to. If an order has had the first delivery made, any items added to the order will be grouped with a future shipment.
- Lennox will attempt to honor dealer-requested delivery dates on a first-come, first-serve basis, based on product availability and shipping capacity.
- Qualifying pick-up orders must be scheduled and claimed in their entirety by program end date.
- At the end of the program, any unshipped or open orders may be cancelled and may not qualify for benefits.
- Items needed immediately may be taken off Stocking and placed on a demand order.
